During the May 28 KEC Executive Committee meeting, the co-op officials made the extremely difficult decision to cancel this year's KEC Summer Meeting scheduled for August 1-3, 2020.

While the KEC Summer Meeting is always a highlight among the electric cooperative family, due to the unusual and uncertain circumstances of COVID-19, the committee cancelled the annual event out of an abundance of caution for the health and safety of the members, staff, sponsors, and other participants.

This decision took into account a recent manager's

survey, local and state orders, travel industry guidance, the limited availability of speakers, the number of participants and origins of travel.

#### Kansas co-op communicators find ways to stay connected

With the cancellation of many industry meetings and professional networking opportunities, one Kansas cooperative communicator found a way to bring together a network virtually. **SARAH FARLEE**, FreeState's public relations/marketing specialist, established a weekly Zoom conference for other cooperative communicators. The conference, playfully titled "Happy Hour," is now in its eleventh week.

Farlee said she first got the idea when the Kansas Member Services Directors Association (KMSDA) spring meeting was cancelled.

"Basically, when KMSDA was cancelled because of COVID-19, I knew I would miss getting together with other people. Then when the CONNECT Conference was cancelled, I knew I would miss that idea exchange with other professional communicators. I was thinking how much I was really going to miss these people, then I realized that I could still call them, so I started the Happy Hour."

Farlee hoped that the informal meeting would provide a platform for the employees to visit and share ideas.

"At the beginning of the pandemic, developing messaging for our members was a moving target and everything was changing so fast," she explained. "It was nice to have a support group who understands what it is you do. We have a unique connection with each other."

Farlee said that another benefit to the group was that it lends consistency to the messaging delivered across the state.

"This group let us know that we were all in this together, and that helped

a lot of people be able to ask for help," she stated. "It's also given us some insight on what we need for future professional development."

The group has been able to share information, ideas, and resources.

"These past 12 weeks has brought phenomenal exchange of ideas and discussions such as how to move forward with events and the new normal. It's also been important to have the statewide's participation," Farlee explained. "For instance, Carrie Kimberlin (KEC's manager of creative services) was able to create a bill stuffer that stemmed from some of our conversation."

Farlee said that the group is beginning to attract other employees from Kansas and Oklahoma cooperatives.

"Participation continues to go up because it's so easy to join. It's pretty simple for me to push some buttons to set this meeting up, but it only works if people embrace it and understand that it's a professional development group. It's only as successful as the people who participate."

And the participants do engage in this new resource.

"Through this group, we've found validation for our concerns and solutions for moving through them. We celebrated our award winners, and we've shared how to better communicate with our members all while having fun. We've been introduced to families and pets and, because of that, we have developed a deeper connection with each other."

Farlee said that she plans to keep the weekly meetings running as long as people want it to continue.

# Alumna from the 1966 Youth Tour shares memories

In the early years of the Electric Cooperative Youth Tour, **PATRICIA** (**PAGE**) **SMITH** was one of 24 youth from across Kansas who traveled from Topeka to Washington, D.C. The Nortonville native was selected for the experience by Leavenworth-Jefferson Electric Cooperative (now part of FreeState) after entering an essay contest.

To help with her essay, Smith asked her father, James Page, to tell her when they first got electricity on the farm.

"He said about 1951 or 1952," Smith remembered. "I said, 'You mean I was born before electricity!?"

When it was time to go on Youth Tour, the students met in Topeka and traveled to Washington, D.C., on a train.

"I remember feeling like I was weaving back and forth after we got off from the train," Smith recalled. "When we left Kansas, everything was fine and dandy, but when we arrived in Washington, D.C., a tornado hit Topeka. The fact that Topeka was struck by a tornado while we were there still stands out in my mind."

Luckily, the rest of their trip was not nearly as hair raising, but just as memorable.

#### Gov. Kelly appoints French to Kansas Corporation Commission

On June 12, Gov. Laura Kelly announced the appointment of **ANDREW FRENCH** to a seat on the Kansas Corporation Commission, subject to confirmation by the Kansas Senate. The KCC is a three-member panel that regulates rates, service, and safety of public utilities, common carriers, motor carriers, and oil & gas production.

French, an attorney from Leawood, KS, is leaving a position with Smithyman & Zakoura in Overland Park. During his tenure at the firm, his caseload included representing a coalition of industrial consumers in many cases before the KCC. Previously, French worked for the KCC as senior litigation counsel. He is a 2010 graduate of University of Kansas (KU) law school and earned a bachelor's in environmental studies from KU.

If confirmed, he will replace Commissioner Shari Feist Albrecht, who was appointed to the KCC by former Gov. Sam Brownback in 2012. including the Oval Office. Smith said that the students were treated with many opportunities throughout their trip, including tours of Mount Vernon, Arlington National Cemetery, and a visit to the Lincoln Memorial.

"We also climbed up the stairs of the Washington Monument," she added.

"It was a fantastic experience," she said about the trip. "I still have my essay in a safe place!"
