Kansas co-op officials prepare for virtual legislative conference

Thirty Kansas electric cooperative leaders registered for the 2021 NRECA Legislative Conference to connect virtually with policymakers on issues important to electric co-op. Virtual events will be held April 19-23.

NRECA will convene its portion of the 2021 Legislative Conference on April 19. The conference begins with virtual advocacy training in preparation for online meetings with members of Congress and administration officials. NRECA will offer virtual briefings on priority policy issues impacting the electric co-op industry, and attendees will have the opportunity to network with their electric co-op peers.

On April 20-23, KEC will schedule online visits with the Kansas congressional delegation. Meeting invitations with login information will be emailed to registered attendees. These virtual meetings will be set in 30-to-60-minute blocks.

Co-ops support KidWind Challenge

Despite the pandemic, Kansas continues to see growth in the KidWind Challenge program.

Coordinated by K-State's Kansas Energy Program, the Kansas KidWind Challenge has gone virtual this year. A total of 26 teams from across the state competed in the regionals event held March 17-19. This event is part of a national program that encourages students to explore the power of wind by building and testing their own wind turbines.

Teams in both the 4th-8th grades division and the 9th-12th grades division submitted a project presentation, created a design notebook, and participated in a virtual trivia event.

Electric cooperative employees were among those asked to serve as judges for this online event. Representing the co-ops were **JEFF ADAMS**, Butler; **SHANA READ**, KEC; and **MIKE TWEEDY**, 4 Rivers retiree.

The top 12 teams of the regional contest were invited to the virtual State Challenge, scheduled for April 22. These teams represent the following schools: Beloit Jr-Sr High School, Dighton Middle School, Kepley Middle School, Green Tech Academy, Wheatland High School, Paola Middle School, and Iola High School.

State winners will be invited to compete in the vitural National KidWind Challenge in June.

Like office visits in past years, this is a valuable opportunity for co-op advocates to engage with elected officials.

Cooperatives registered to attend the conference include Bluestem, Butler, CMS, DSO, Heartland, KAMO, KEC, KEPCo, Midwest Energy, Nemaha-Marshall, Pioneer, Sumner-Cowley, Sunflower, Victory, and Tri-County.

For those who use machinery such as tip trucks, over-height vehicles, excavators, cranes, or augers, consider the motto "look up and live" before commencing work. Be aware that powerlines may be above you and pose a risk to you and others nearby.

From April 6 through 9, 30 employees representing 20 electric cooperatives attended KEC's virtual HR Summit. The online conference was held 9 a.m. to 11 a.m. each morning.

Sessions of this virtual event included Defensive Driving in a Dangerously Distracted World by Right-Lane's DONNA BAYLESS and SHARON **WINTER**, a benefits update by NRECA's MALACHAI STURLIN, a discussion of pandemic policies and best practices by HR Partner's KRISTINA DIETRICK, The Fund Company Built for Cooperatives by RE Investment Corporation's **BRIAN ALLEN**, a review of onboarding and employee engagement resources by NRECA's HOLLY WETZEL, an employment law update by attorney LISA MARTIN, and a discussion of how to protect employees and cooperatives from fraudulent unemployment claims from Western's VALERIE SCHNEIDER. Midwest Energy joins EV charging collaboration

Midwest Energy announced it has joined a collaboration group with nine investor-owned utilities, promoting the construction of a multi-state network of electric vehicle (EV) charging stations throughout the Midwestern U.S.

Midwest Energy signed a memorandum of cooperation with the other utilities, pledging that the co-op would pursue the completion of a foundational EV charging network, to soon allow EV owners to drive from Detroit to Colorado, or from northern Michigan to Texas, knowing they can charge their vehicles along the route.

"Automakers worldwide are committing huge investments in electric vehicles, with some signaling they're phasing out fossil fuel engines by 2030," said Patrick Parke, Midwest Energy's CEO. "EVs are coming quickly, and by joining this group, Midwest Energy is better positioned to serve not only our customers once EVs become commonplace here, but also visiting drivers across western Kansas."

Midwest Energy does not currently own or maintain any EV chargers, but has worked with private companies, including Electrify America and Tesla to install fast chargers in parking lots along Interstate 70. Parke said that joining the collaboration group is well-timed, as electric vehicle strategies are a part of the co-op's business plans.

Heartland

Heartland held a drive-in annual meeting at its headquarters in Girard on March 30. This year, 142 members registered. Each received a \$25 bill credit and was entered into a drawing for \$1,000 in cash prizes held the following day.

After registration, members were invited to watch the meeting from their vehicles where the meeting could be heard by tuning into a local FM broadcast, or they could watch a livestream on Facebook and YouTube.

During the meeting, Heartland honored board member **BERNIE O'BRIEN** who stepped down after almost 45 years of service.

Re-elected to the board were **ERNEST TROTH** and **STEVE MCFARLAND**. The seat previously held by Mr. O'Brien will not be filled as the board now consists of eight members as stipulated by the cooperative's bylaws.

Rolling Hills

Rolling Hills had an abbreviated annual meeting at the co-op headquarters in Beloit on April 9. Out of concern for member health, restrictions on gatherings, and related issues, attendance at the annual meeting was limited to co-operative board members and staff. This was the last meeting for Board President **BOB FREDRICKSON**, as he has retired from his position. He was presented a meter lamp to commemorate his years of dedication.

The board election was held via mail ballot. Newly-elected was **SARAH GOSS**. Re-elected were **PAUL WILSON** and **JUSTIN TROST**. Rolling Hills hopes to host an informational meeting and dinner for members this fall if pandemic conditions improve.

Alfalfa

Alfalfa's drive-through annual meeting was held at the Cherokee High School Gymnasium in Cherokee, OK, on April 9. The co-op had 514 members register, and each received a thermal tote bag and a 6-port USB charging station.

For the members to register, they at the option to register at the co-op's truck barn, the Cherokee High School sports complex, or at the high school just prior to the start of the meeting. Members could attend in person or listen to the meeting by tuning into a local FM station which could be heard throughout most of the town of Cherokee.

Meeting topics consisted of Operation Round Up, the February winter event, and the new headquarters facility. Alfalfa also retired more than \$2 million in capital credits this year, the most significant refund in the co-op's 85-year history.

Re-elected to the board were LARRY DEWITT, JOHN REGIER, and STEVE ECK.
