Kansas Electric Cooperatives hosts eventful 71st annual meeting

Representatives of Kansas electric cooperatives gathered in Topeka Jan. 26-29 for KEC's 71st annual meeting. The attendees discussed issues and challenges facing the co-ops, listened to a wide range of speakers and participated in special presentations and events.

Monday was dominated by Kansas politics. Senate Majority Leader Terry Bruce and House Minority Leader Paul Davis discussed their expectations for the 2013 Kansas Legislature focusing primarily on their political party's vision for fiscal and tax policy, and how to fund essential government programs in light of a projected budget deficit.

Kansas Governor Sam Brownback also talked tax policy as well as the potential for energy production in the state.

"The United States is now looking at being a major energy exporter," said Brownback. "With our energy production that's happening in Kansas, we are looking at being the largest energy-producing nation by 2020."

He pointed out the natural gas and wind operations, methane plants, and oil production within Kansas. He also discussed the economy at the state level, noting that Kansas needs to be more competitive with tax policies.

"We can't prosper in the state if one part is growing and one part is declining," he said. "One of the biggest things we as Governors do is to get our states to grow. We want our kids and grandkids to have the opportunity to move back if

they want to."

Kansas legislators were the focus of the evening as well during KEC's Annual Legislative Reception. Approximately 70 members of the Kansas Legislature dropped by through the three-hour reception to visit with cooperative constituents. Many other state officials were in attendance, as well as Kansas Congressman

Development; Mike Lewis, RUS General Field Representative; and Brian Briggeman, Director of the Arthur Capper Cooperative Center at Kansas State University.

KEC's Loss Control, Safety and Compliance Department recognized cooperatives who have earned the "No Lost Time" safety award and the NRECA Safety Achievement certificate.

In a special presentation, the president and CEO of the Kansas Cooperative Council (KCC), Leslie Kaufman, recognized Paul Seib, Jr., for being selected to the Kansas Cooperative Hall of Fame. Seib is a director for Lane-Scott Electric Cooperative and will be inducted in March.

Bruce Graham and Kaufman presented Steve Parr, KEPCo's CEO, with a Resolution of Appre-

> ciation from the KCC. Graham is on the KCC Board and authored the resolution recognizing Parr for his career of service not only to KEPCo but to the cooperative movement across the nation.

Federal court won't rehear EPA on air rule

A federal court won't reconsider a decision that nullified major EPA rules to cut power plant emissions that cross state lines. A three-judge panel ruled 2-1 in August to toss out the rule, and last month the court announced that a majority on a wider panel of judges voted against a full-court rehearing.

Utilities planning to address cybersecurity shortfalls through coalition

President Barack Obama said during his State of the Union address that he had signed an executive order aimed at protecting government and businesses from what he called "the rapidly growing threat from cyberattacks." In response, utilities are forming a coalition in order to share emerging cybersecurity threat information, employee training, and cybersecurity best practices. The group will include 11 electric, energy, gas and chemical companies.

Pioneer improves employee efficiency with renovations

Pioneer Electric Cooperative, Inc., is in the process of renovating its office and warehouse spaces.

The remodeling project started in 2010 when its warehouse received a 7,000 squarefoot facelift and the linemen's room was expanded.

"Before, we had to work around different things," Mark Shogren, Manager of Warehouse, said. "But now that it's done, we're out where the materials are. It gives us more room to effectively do our work."

Pioneer has yet to finish all of its changes. The accounting department will move into the current assembly room to gain more space for cubicles. The current accounting space will be divided to create an office and a meeting room.

Rae Gorman, Communications Coordinator, said that it's a matter of efficiency and that the departments had out-grown the previous space.

The communications department is currently reorganizing, and will have a new layout and newly painted cubicles by the end of this year.

Realigning and painting cubicles, adding on to warehouses and moving departments gives Pioneer employees more space to do their jobs comfortably and effectively.

"Everybody involved really enjoys our new facility and it improves productivity when people like where they work," Shogren said.

Electric cooperatives help to protect members from scammers

Cooperatives in western Kansas have experienced a rash of scams in their service territories.

The scammers have tried, both in-person and over the phone, to gain personal information and payments from members of Midwest Energy, Pioneer and Victory electric cooperatives.

Midwest reported one incident where a Spanish-speaking male targeted owners of a local grocery store. The scammer claimed to be from the "electric company" and already knew the couple's account number.

In Pioneer's territory, a man claiming to be from the utility knocked on a member's door demanding \$100 and threatened to disconnect the meter.

Scammers in Victory's service area demanded members buy a MoneyPak card to pay their bills or be disconnected. A few members have reported falling for this scam, but the co-ops estimate that there are more victims who haven't reported.

The co-ops have reached out to their members to alert them.

Midwest and Pioneer sent news releases to area newspapers and radio stations, including two Spanish-speaking stations. It also posted information on its Facebook page and website.

"If we can help someone avoid falling victim to any of the money-collecting scams, we've been successful," said Rae Gorman, Pioneer.

Victory employees were interviewed on the local nightly news to warn their membership.

Victory's television appearance was rounded out through the use of bill stuffers, radio spots, e-mails to local businesses, posts on Facebook and information in the local news section in *Kansas Country Living*.

"We've done everything that we could do," said Josh Schmidt, Victory. "We encourage our members to let us know and to call the local law enforcement officials."

AT Department completes move

KEC's Apparatus Testing Department has moved from a leased facility in Burlingame to a permanent location in Osage City.

Apparatus Testing spent November and December moving its inventory into the larger building.

"It used to be scattered, a little here, little over there," said Danny Seele, Director of Apparatus Testing. "Now it's all right here."

The new building has larger rooms and more space for items such as the oil circuit recloser inventory. While the old location required shared work areas, the new location allows two work stations and a paint booth area to operate simultaneously without interference.

The move to the new facility is not the only change the department has faced recently. Apparatus Testing has also upgraded its inventory management system, utilizing the full potential of KEC's current accounting software

"The software will give us more tracking and reporting capabilities," said Angela Howard, KEC's Staff Accountant.

The new facility, which came with perimeter fencing and a security monitoring system, also allows Apparatus Testing to better protect

their equipment. Although some items have yet to be unpacked and the team has plenty of work to do, Seele is confident the change will help them serve members more efficiently.
