KEC hires Estes as new editor of Kansas Country Living

With the announcement of Larry Freeze's upcoming retirement, KEC has hired Vicki Estes as the new editor of Kansas Country Living.

Estes brings more than 25 years of writing experience.

She began her career with the Kansas Press Association where she edited a monthly publication and a weekly newsletter, both of which offered trade news and trends and legislative updates for Kansas newspaper publishers and editors.

She has served in several leadership roles including managing internal and external communications for Washburn University School of Law, Westar Energy and St. Francis Health

Estes realized her life-long desire to become a newspaper columnist when the Topeka Capital-Journal selected her to write a twice-weekly column nearly eleven years ago. She continues to add a lighter side to the newspaper's editorial page with her "slice of life" column that rotates with syndicated columnists and other local writers.

Most recently, Estes handled internal and external communications for Newcomer Funeral Service Group, where she wrote a weekly employee communique designed to streamline organizational communications, as well as a monthly newsletter highlighting employee and company success stories.

Electric cooperatives work together for \$1.816 million loan

Midwest Energy and Western Cooperative Electric recently announced the award of a \$1.816 million loan from the U.S. Department of Agriculture's Rural Economic Loan and Grant (REDLG) Program, which will be used by BJKLM Development Company, LLC, to fund the site development and building construction of a large implement dealership in Hoxie. The dealership will be operated by BTI and is expected to add 20-25 jobs to the Hoxie economy.

The loan, announced by Agriculture Secretary Tom Vilsack on April 1, was one of 38 loans and grants totaling \$31 million to support job creation efforts, business development and strengthen economic growth in rural communities in nine states.


Midwest Energy and Western each requested \$908,000 from USDA, essentially guaranteeing their half of the loan. It marked the first time in Kansas two cooperatives have collaborated on a REDLG application, reflecting a new era of confidence in development of projects requiring larger sums for investment.

"We're pleased to partner with Western, and we're pleased for the growth that this project will bring for the residents of Sheridan County," stated Earnie Lehman, President and General Manager at Midwest Energy, noting that Midwest Energy provides electricity to the city of Hoxie, while Western serves the southern portion of Sheridan County.

"Though this is the first collaboration between Western and Midwest on a REDLG application, this isn't the first, and won't be the last time Western and Midwest work together on issues impacting their member-owners," said Darrin Lynch, General Manager at Western. "Concern for community is one of the seven cooperative principles by which we live. As such, Western is honored to support this project. It represents a step of forward progress and development for rural Kansas."

Kansans voice EPA regulation concerns

A strong turnout of 20 electric cooperative representatives underscored concerns to the Federal Energy Regulatory Commission (FERC) at a recent conference on reliability impacts of EPA's proposed new regulations.

Corey Linville, Sunflower's Vice President of Power Supply and Delivery, urged FERC to get EPA to address significant flaws in its proposal that could harm reliability and electricity markets.

Sunflower's President and CEO, Stuart Lowry, was part of a team of G&T leaders who met with EPA Administrator Gina McCarthy and EPA Staff about the impact of the proposed Clean Power Plan 111(d) rule. The goal of the April 13 meeting was to keep cooperative industry concerns forefront during this critical period as EPA works to develop a final rule.

Turner named as CEPC's CEO

The Central Electric Power Cooperative (CEPC) Board of Directors has named Christopher M. "Chris" Turner as its next CEO. He begins his new duties in July upon the retirement of Donald Shaw, who has served CEPC for 42 years.

Turner currently serves as the CEO/Administrator of the Southwestern Power Administration (SWPA) in Tulsa, OK. SWPA markets power to 102 preference customers in Kansas, Missouri, Oklahoma, Arkansas, Louisiana, and Texas. SWPA customers are composed of 21 cooperatives, three federal facilities, and 79 municipalities. SWPA has approximately 200 full-time employees and 50 contractors in four locations.

In his role as CEO of Central Electric Power Cooperative, Turner will also serve as a voting member on the Associated Electric (AECI) Board of Directors representing CEPC's eight member distribution systems. AECI in Springfield, MO, provides wholesale power to Central and its eight distribution cooperative members.


CEO Steve Epperson introduced a video outlining the recently commissioned customer satisfaction survey and details about the Rubart Station.

Kansas electric co-ops recover from spring storms

Straightline winds of 100 miles per hour during the night of April 3 caused system-wide power outages for several co-ops around the state including Ark Valley,



Midwest Energy had more than 530 damaged poles within its service territory following the April 3 storm.

Butler, and Sedgwick County. These co-ops requested Mutual Aid assistance to repair damage and restore power to their members. Most restoration was complete by April 5.

Line crews for all three co-ops worked continuously from the moment the storm hit. Crews from other co-ops were called to help speed up the restoration of power to the affected areas. DS&O, Flint Hills, Rolling Hills, Southern Pioneer, and Victory sent line crews to assist.

Ark Valley estimated 186 damaged poles which caused outages to more than 700 members. The co-op also had two substations without service

due to downed transmission lines owned by Westar Energy.

Butler reported 36 distribution poles and four transmission poles down affecting approximately 3,500 members.

Westar Energy had damage issues which also affected restoration of power to some of Butler's members.

Sedgwick County suffered 80 broken poles, most of which were three-phase, including 1/2 mile of transmission and a mile of double-circuit line, affecting 4,500 meters. They utilized two contract crews in addition to mutual aid, effectively tripling their normal line personnel.

In addition to the three cooperatives that requested Mutual Aid assistance, Midwest Energy also reported close to 10,000 members without power. The cooperative had 530 damaged poles.
