Carl Holmes honored at NRECA Region 7 meeting

Longtime Kansas state representative Carl Holmes was presented with the 2012 NRECA Regional **Outstanding Service** Award last month at the Region 7/9 Meeting in Salt Lake City, UT. He was nominated by KEC for the honor.

The award recognizes individuals

who have made significant contributions to the electric cooperative program, especially at the state and regional level.

Holmes has served the Liberal area in the Kansas House of Representatives since 1984. He has been the chairman of the House Utilities Committee for nearly 25 years, as well as the Agriculture, Natural Resources and Administrative Rules & Regulations chairman.

"I felt quite humbled and extremely honored," Holmes said when learning of the award. "An individual honor is only possible when other individuals are willing to follow your leadership and support your vision for the future."

"Rep. Holmes understands the cooperative business model and has been a cooperative member most of his life," stated Bruce Graham, KEC's Chief Executive Officer, in his nomination of Holmes to NRECA. "He has always protected the cooperatives from harmful or unfair legislation and has supported cooperative initiatives in his leadership role."

"Rep. Holmes

has educated new legislators and fostered their involvement in assisting the electric cooperatives of Kansas with our legislative efforts," added Dave Holthaus, KEC's Vice President of Government Relations. "Rep. Holmes is truly the leading energy voice in Kansas and the region and his expertise on both the federal and state levels will be missed."

Holmes was defeated for re-election in last August's primary. Despite the loss of his House seat, Holmes says he has fond memories of his service to Kansas.

"I have had 36 great years of elected political office - exactly half of my life - both in city and state government," he said. "I have enjoyed public service and working to develop solutions for energy and utility issues."

Holthaus promoted to VP

As part of the KEC department restructuring, Dave Holthaus has been promoted to the position of Vice President of Government Relations. Holthaus has 10 years of experience as KEC's Manager of Government Relations and has 33 years of lobbying and utility experience. In this new position, Holthaus will manage state government and regulatory networking, direct state legislative activities, and coordinate Congressional communications.

"The KEC Board of Trustees recognized that government and regulatory relations are key components in an effective association and approved enhancement of the department by hiring a second staff member in this area," said John Blackwell, President of the KEC Board of Trustees. "The KEC Organization Assessment planning process prioritized this goal and with these changes, we will be able to provide even stronger member value and service as a result."

KEC to utilize new technology in safety workshops

A new audience response system is making its way into the KEC's Loss Control, Safety and Compliance Department. The goal of this interactive polling system is to keep participants involved and focused during training.

Each participant receives a remote polling device the size of a credit card to answer questions during a presentation. By clicking a single button, the results are displayed immediately to both the instructor and participants. This instant feedback allows the instructor to gauge the audience's understanding of the material. If needed, the instructor can go back and spend more time on complicated topics.

The answers are all tabulated anonymously, which makes the audience more comfortable with responding.

"As soon as everyone gets accustomed to the system, and once they realize all answers are anonymous, meetings will run smoother and participants will get a lot more out of training sessions," said Larry Detwiler, LCS&C director.

EPA, financial workshops, impact of new oil topics at district meeting

Kansas electric cooperative trustees, managers, and key staff gathered last week at the four KEC district meetings in Dodge City, Fall River, Hays and Topeka.

CFC's Tom Beamon and Sherry Sharp gave an economic update. There were also presentations on KEC's services and a brief overview of the KEC 2013 budget.

KEC's Dave Holthaus spoke about EPA regulations affecting electric power. These regulations can be summa-

rized by what the NRECA calls "The Big Five" – Cross-State Air Pollution Rule, Mercury and Air Toxics Standards, Coal Ash Regulations, Cooling Water Intake Rule, and Greenhouse Gas Regulation.

Another topic

discussed was the impact of new oil on Kansas cooperatives. Leading these presentations were KEPCo's Mark Barbee, Sunflower's Don Gulley, and Alfalfa's Colin Whitley.

The luncheon speakers included several local legislators.

"The district meetings had a great turnout this year," said KEC's Bruce Graham. "Based on the evaluations, participants seemed to get a lot of information from the presentations and were overall pleased with the meetings."

Kansans join new safety communications initiative

Several Kansas co-op communicators have joined a newly-created group under the Safe Electricity umbrella to address communication needs in energy education.

"It's an opportunity to network and to share ideas on a national level," said Safe Electricity's Molly Hall, who will oversee the Energy Education Council (EEC) Member Assembly.

"We get regular feedback from Safe Electricity participants, but we know we are not hearing from everyone," Hall explained. "The assembly will be a two-way dialogue with more people, to make sure we are meeting their needs."

The mission of the council is to promote safety by disseminating useful articles and information and helping members understand renewable resources and energy efficiency.

Kansas will be represented by: Ann Fitzmorris, Radiant; Anna Foley, Prairie Land; Carrie Kimberlin, KEC; and Mike Morley, Midwest Energy.

Each delegate will serve a twoyear term, participate in bi-annual webinars, and provide input for various safety communication materials. The assembly hopes to provide the tools and materials needed for co-ops to communicate safety messages to their members.


Victory, earned the CCD.

Today's electric utility environment imposes new demands on electric co-op directors, particularly increased knowledge of changes in the electric utility business, new governance skills and a working knowledge of the cooperative principles. Electric co-ops in Kansas have a commitment to work through KEC to sharpen this body of knowledge for the benefit of their members.

KEC headquarters receives an energy audit

Dave Sanders, Mulvane, and Chad Pederson, Lawrence, visited the KEC headquarters facility on October 18 to conduct an evaluation of the building's energy systems. They are associated with PI Group, Inc., a Topeka



"Our purpose is to get a feel for how the building is performing," said Sanders, who is a member of Butler Electric Cooperative. "We will spend two to three hours analyzing and gathering data about the building's energy usage, comfort and other factors."

The facility, which opened in 1991, was built with a geothermal heating and cooling system.

"It was leading edge technology at the time," Pederson said. "It will be fun to look at the system, because we don't find

them in a lot of places."

"It's still a great technology," Sanders said of the ground loop system. "After 20 years, there may be ways it can be tweaked or improved. That's one thing we'll look for."

The report is expected to also analyze lighting and other opportunities for improved energy efficiency.
