Mid-Kansas Electric Company to break ground on Rubart Station

On April 9, Mid-Kansas Electric Company, LLC will hold its groundbreaking celebration for Rubart Station, the company's 110 megawatt electric generating station located 13 miles east of Ulysses.

Officials of companies involved in construction, Mid-Kansas board members, and state and local dignitaries—along with Perry Rubart, longtime Pioneer Electric trustee after whom the facility is named—have been invited to attend this event.

The 110 megawatt station will comprise 12 natural gas reciprocating engines designed by Caterpillar Generation Systems, marking the first installation of Caterpillar's new G20CM34 sets.

"It's exciting to break ground on a station that will bring great benefits to our members and the region," said Allan Miller, Mid-Kansas board chairman. "These units will help meet our members' growing need for electricity and can be deployed individually within minutes, allowing for rapid response to wind and market conditions."

On-site work began in late February in preparation for arrival of the units in the fall. Caterpillar will ship the units from Rostock, Germany, to Houston, TX, from where they will be transported by rail to southwest Kansas and then trucked to the site.

During construction, the project will generate an estimated 150 jobs. Once operational the

facility will create six to 10 jobs.

Lesser Prairie Chicken activity continues

KEC has been working on behalf of its membership to express concerns about the potential ramifications of a pending decision by the US Fish and Wildlife Service (USFWS) to list the Lesser Prairie Chicken (LPC) as a threatened species.

If the LPC were listed and habitat protected, the construction of utility facilities would be restricted or require a cumbersome permit process, including expensive mitigation steps. While a decision is not required until Sept. 30, KEC and its member G&Ts have been engaged in the issue to meet several key deadlines for comment.

Those initiatives include: KEC's CEO Bruce Graham wrote and filed with USFWS comments on the proposed listing; KEC supported another set of comments filed by municipalities and landowners in the affected areas; KEC has communicated its concerns to its Congressional Delegation; and the March Kansas Country Living CEO column was dedicated to this topic.

Most recently, Graham joined several statewide managers in a meeting with Dan Ashe, Director of USFWS, to ask the agency to defer a listing while a five-state voluntary conservation plan is crafted.

KEC has alerted NRECA to ramifications of a court case that requires the USFWS to make decisions on 250 other species now on the list of candidates for protection under the Endangered Species Act. As a result, the topic will now be part of the NRECA Legislative Conference later this month.
