Senators, industry leadership featured at KEC Summer Board Meeting

Hundreds of electric co-op trustees, managers and key staff heard from a variety of speakers at KEC's Summer Board Meeting in Overland Park on Aug. 4.

Senator Jerry Senator Jerry Moran and Jo Ann Emerson, NRECA CEO, were among the Moran opened the presenters at the 2014 KEC Summer Board Meeting.

meeting by sharing his belief that rural America is something worth fighting to preserve, which is his motivation for being in a public office.

He detailed several rural issues and complimented the electric cooperatives for their selection of student delegates on the annual Electric Cooperative Youth Tour.

"When I need a new perspective, I run to the World War II Memorial. We need to be motivated and follow the lead of those who made the ultimate sacrifice rather than focus on whether the Republicans score points or the Democrats score points," Moran stated. "We have to get back where the focus is not the game of politics, but to what these youth tour students represent. There is no other better group of kids."

Senator Pat Roberts also stopped by the training workshop held on Saturday, Aug. 2 to say hello to the attendees.

The lunch speaker was NRECA's Jo Ann Emerson who discussed NRECA program changes in response to member requests and how Kansas co-ops are affected by regulatory overreach.

Emerson said, "It's critical for us to tell our story as often as we can. Your voices do make a difference."

Denise Aranoff-Brown, Touchstone Energy, detailed the mission of the Touchstone Energy brand and reviewed the various programs available to member-cooperatives.

"Touchstone Energy exists to demonstrate and to enhance the value of the cooperative difference," Aranoff-Brown stated.

Duc D. Lai, CFC, explained why co-ops should be concerned about cyber security and

encouraged the co-ops to develop policies for cyber security and social media.

"Cyber means having to do with computers," Lai explained. "But cyber

security has more to do with people than with computers."

Jackie McClaskey, Kansas Department of Agriculture, stated that agriculture is the key to growing the Kansas economy, discussed how the agency is preparing for agricultural emergencies, and reviewed the Governor's vision for water resources in Kansas.

Kristina Dietrick, Creative Business Solutions, provided an overview of the recent employment law changes and reviewed other relevant human resources topics.

Charles Terrill, KEPCo, reported on the SPP Day Ahead Markets. He compared real time and day ahead pricing and explained how Kansas G&Ts are affected. Stuart Lowry, Sunflower, reported on EPA's proposed carbon dioxide restrictions for new and existing units.

Midwest Energy's Mike Morley reported on the co-op's community solar project, and KEC's Shana Read reviewed the summer's youth tour programs.

The KEC Auxiliary program featured entertainment by Curtis Waltermire; gardening tips from Meg Mullett, Johnson County Extension Master Gardener; and a presentation by Karen Kornacki, Sports Anchor at KMBC. In addition, the Auxiliary hosted a silent auction that raised \$2,266 for KEC's youth programs.

Prior to convening the summer board meeting, Mike Core facilitated the CCD Course "Understanding the Electricity Business." In addition, Ken Holmes and Mike Core facilitated two Board Leadership courses "Appraising and Compensating the CEO" and "Risk Oversight – The Board's Role in Risk Management."

18th annual KCRE golf tournament to be held in Salina

their time, and it accounts for a large portion of KCRE's annual funding. Other funding comes from the annual membership dues and the annual silent auction.

The KCRE donations are important to candidates who are running for Kansas offices to assist them in getting their campaign message out to voters. No KCRE dollars are used for meals, entertainment or gifts.

Budget Pro workshop

KEC has re-scheduled the CFC Budget Pro workshop. This two-day training will be held Sept. 18-19 at the Ambassador Hotel in Wichita.

The purpose of the workshop is to learn how to prepare a 12-month operating budget for a distribution co-op using a CFC-created spreadsheet template. The course will be facilitated by CFC's John Grant and Johnny Vaughn.

The workshop is Sept. 18 from 9 a.m. – 4 p.m. Lunch is provided and there will be a dinner reception from 5:30 - 7:30 p.m. On Sept. 19, the workshop will run from 8 a.m. – noon A box lunch will be provided. There is no registration fee for this event for KEC members.

Attendees will need to bring a laptop with Microsoft Excel 2010 or higher - OR - Microsoft Windows XP or higher. The laptop should have memory of two gigabytes or higher, as well as a USB port. A flash drive will be provided at the workshop.

This program will provide a maximum of nine CPE credits in Specialized Knowledge & Applications.

Co-op linemen to deliver safety message at Kansas State Fair through the Kansas Energy Expo

Concerts, carnival rides, and cotton candy —the Kansas State Fair brings enjoyment for all ages. As part of fair's activities, Kansas electric cooperatives and Touchstone Energy cooperatives of Kansas are once again co-sponsoring a high-voltage line safety demonstration, Sept. 8-12.

Located in the recently renovated Ad Astra Pavilion (east of the Oz Gallery), the electric cooperatives will be joined by the Kansas Energy Expo which is new to this year's State Fair.

The Kansas Energy Expo is sponsored by the Kansas Corporation Commission and will incorporate interactive exhibits representing various Kansas utilities. Volunteers are still needed to help with the Energy Expo Information Booth.

To kick off the first year of the Kansas Energy Expo, KEC is sponsoring the Touchstone Energy Hot Air Balloon. The balloon is scheduled to fly one day between Sept. 8 - 10, in accordance to the weather. On Monday, Sept. 8, LED Lucy will be present to welcome the fair audience to the high voltage safety demonstration.

Kansas electric cooperative linemen will present the interactive demonstration using real electric equipment and

their "volunteer" stick man to show the importance of education and public safety around power lines. The presentation will help viewers learn safety precautions, what protective gear linemen use, and what happens

if a person comes in contact with an energized line.

"It is important we use electricity safely and that everyone knows the proper precautions to take," said Brian Dreiling, Manager of Energy Services at Midwest Energy. "That is what we encourage during

the demonstration at the State Fair."

Midwest Energy will provide the demonstration materials, a narrator, and a trainer for each day of the safety presentation, and DS&O, Wheatland, and Heartland have volunteered their linemen to operate the demonstration. The Midwest Energy volunteers include Brian Dreiling, Nate Stryker, Les Loker, Alex Breeding, and Greg Swob; the DS&O volunteers include Aaron Taylor and Mike Ecton; the Wheatland volun-

teers include Matt Hosler, Trent Suchy, Kyle Strickert, and Curtis Peterson; the Heartland volunteers include Brian Combs and Cody Conwell.

The high voltage safety demonstration coincides with Kansas'
