Western linemen risk their lives in an effort to save driver

On July 11, 2013, at 2:30 a.m. Kelly Owens, Western Cooperative Electric's foreman, and Nate Budig, journeyman, left their WaKeeney warehouse to check on an electrical outage in Gove County.

As they were driving on I-70, they came upon a one-vehicle accident. The rollover vehicle was not only in the lane of traffic but was partially on fire with the driver unconscious and seat belt engaged.

Time was of the essence, and emergency personnel had not yet arrived on the scene. Owens and Budig took action and removed the driver from the vehicle moments before the vehicle was totally engulfed in flames.

While sadly the driver did not survive, these

linemen never hesitated for a chance to save a life. When both linemen were asked about why they had placed themselves in danger with the vehicle partially on fire, their reply was "Why would you not make an attempt?"

"We are extremely proud of these linemen, not only for their quick response to this accident but for placing themselves in harm's way each and every day to keep the lights on for the rest of us," said Darrin Lynch, Western's General Manager.

Lynch continued, "Our linemen represent what Western, and rural electric cooperatives, are all about-doing what needs to be done. Western's safety training is ongoing and our linemen continue to meet challenges without hesitation."

USDA seeks applications for grants to create jobs, economic opportunity in rural areas

The U.S. Department of Agriculture seeks applications for grants that will be awarded to organizations to help rural businesses create jobs and spur economic development.

USDA is making \$5.6 million available through the Rural Community Development Initiative (RCDI), a program that serves as a catalyst for economic growth in rural areas.

Mid-Kansas Electric Company receives siting approval for Elm Creek-to-Summit transmission line

Mid-Kansas Electric Company, along with ITC Great Plains, LLC, received siting approval from the Kansas Corporation Commission for their portion of the Elm Creek-to-Summit high-voltage electric transmission line project in north central Kansas.

The 60-mile, 345-kilovolt transmission line will connect the ITC Great Plains Elm Creek Substation, approximately four miles northwest of Aurora, to Westar Energy's Summit Substation, located five miles northeast of Assaria. ITC Great Plains and Mid-Kansas will construct, co-own and operate the northern half of the line in Cloud and Ottawa counties. Westar Energy will build, own and operate the southern half of the line. The project also will involve upgrades at both substations.

KEC to offer NRECA Supervisory courses in Topeka

KEC is offering the NRECA Supervisory Training courses on Oct. 14-18 at KEC's headquarters in Topeka.

This program delivers instruction on core competencies required of supervisors in the areas of leadership, communication, and basic administrative skills. NRECA developed the curriculum based on a set of supervisory competencies identified by new cooperative supervisors, experienced supervisors, and CEOs.

This "fast track" offers all nine interactive, co-op specific half-day courses in one week. Participants can register for some or all of the modules they need to fulfill their Supervisory Training certificate.

Bryan Singletary, NRECA, will facilitate these courses.

Member registration is \$250 per module or \$2,000 per attendee for all nine modules. Registration includes materials and lunch (no lunch will be provided on Friday). Registration deadline is Oct. 4

Rolling Hills' Jeardoe helps win "pitch" for Kansas

Melvin Jeardoe, Rolling Hills Electric's Line Superintendent in Belleville, recently helped the Kansas Horseshoe Pitchers Association win the bid to host the World Horseshoe Pitching Championships.

The tourney will be held in Topeka July 13-25, 2015, and could attract up to 2,000 participants.

Jeardoe, regional director of the state association, said delegates from the National Horseshoe Pitchers Association chose Topeka over Charleston, WV, and Wichita Falls, TX. Topeka edged Charleston for the 2015 bid by one vote.


This championship will be the first time the national tourney has come to Kansas since the inaugural event was held in Bronson, KS, in 1910.

"We bid in 2007 and that's the year we missed by five votes," said Jeardoe. "We looked at it again over the last couple of years and we decided to go for 2015."

Competitors come from across the United States and Canada, as well as

several other countries.

The event will include 50-75 indoor courts set up at the Kansas Expocentre and 18 practice pits in Gage Park.
