Board of Trustees announced the selection of Bruce Graham to become the eighth executive officer in the 70-year history of the association.

The board completed interviews of the candidates the first week of January.

"I want to thank the KEC Board of Trustees for this opportunity," Graham said. "KEC has a history of extraordinary leaders and leadership in the state of Kansas. I am privileged to be asked to work with the Board, the membership and the

professional staff toward a common goal of outstanding service to our member cooperatives and our member consumers."

Keith Ross, KEC's Board President, said that the KEC board selected Graham following a national search conducted through the National Rural Electric Cooperative Association (NRECA) Executive Search.

"We're excited to have Bruce as our statewide manager. His cooperative background and the industry experience he received in Indiana are going to be very useful to us," said Ross. "We have a great staff, and we know that Bruce will keep us going in the right direction."

As the executive vice president, Graham will oversee and direct a 22-person staff that assists member cooperatives with a variety of specialized services, including government relations, safety and regulatory compliance, and youth and education programs.

Graham has served as CEO of the Indiana Statewide Association of Rural Electric Cooperatives, Inc., the trade association for Indiana's 39 electric cooperatives, since 2006. During his leadership, association membership grew to include all Indiana electric cooperatives, and participation increased with the regulatory and training programs.

Graham said, "I very much appreciated the occasion to lead the Indiana Statewide Association for the past six years. During that time, we expanded and improved many association services, and I'm proud of those accomplishments. I am excited though to return to Kansas to best utilize my knowledge of the industry in the Sunflower State."

Prior to his time in Indiana, Graham was KEPCo's vice president of member services and external affairs. During his 17-year career at KEPCo, he was responsible for communications and government relations at both the state and

federal level. He also supervised and directed KEPCo's marketing and economic development efforts.

Graham is a past president of NRECAs Council of Rural Electric Communicators (CREC). He has also been active in Touchstone Energy, the national electric cooperative brand and standards program. Graham is a Certified Cooperative Communicator and is a graduate of Leadership Topeka.

Graham is expected to take his new position by March 1, 2012, replacing Stuart Lowry who has accepted the CEO position at Sunflower Electric Power Corp. Lowry has served at KEC since June of 2004.

Graham grew up in Manhattan and attended Kansas State University. His wife, Kathy, is a native Kansan, grew up in Sedgwick County and also attended K-State. They have two sons: Chris lives in Birmingham, AL, and Kevin lives in the St. Louis area.

## Repayment for energy efficiency improvements through utility bills a growing trend

On-bill financing, an innovative tool that allows customers to pay for energy efficiency investments though utility bills, is becoming more widely available, according to a new study. The study was released by the American Council for an Energy-Efficient Economy and profiles 19 existing programs in 15 states. The study finds that these programs are poised to address financing gaps that have not been historically addressed by other energy efficiency financing mechanisms.

#### Co-ops disappointed in the Administration's actions on Utility MATS rule

NRECA's Glenn English expressed disappointment in the final Utility Mercury and Air Toxics Standards (Utility MATS) issued by the EPA. NRECA expressed doubt the utility industry as a whole could meet the new standards in three years. The deadline creates special problems for cooperatives. Often, small systems must compete with larger utilities for the limited number of engineering experts and equipment vendors.

## Consumer Interest in Plug-in Electric Vehicles Declines

As public awareness of electric vehicles continues to build with the increase in model launch activity, a new survey finds that consumer interest in purchasing PEVs has gradually declined over the past two years. In the 2009 edition, 48% of respondents stated that they would be "extremely" or "very" interested in purchasing a PEV. In 2011 it fell to 40%.

## Pioneer's Perry Rubart selected as 2012 Hall of Fame Inductee

Perry Rubart, a board member at Pioneer, will be inducted into the 2012 Co-op Hall of Fame.

The Hall of Fame, sponsored by the Kansas Cooperative Council, is valued for recognizing the contributions of co-op pioneers and honoring those who have gone "above and beyond the call" in advancing the cooperative philosophy.

Rubart has given decades of service to rural electric

cooperatives as a board member for local and regional cooperatives and represented Kansas electric cooperatives on the National Rural Electric Cooperative Association board.

"He is a great advocate for the members of Pioneer Electric," said Steve Epperson, Pioneer's CEO. "His wisdom, commitment and dedication leaves a positive impact on each board on which he serves."

Rubart's commitment to advancing rural electric cooperatives reaches beyond state lines to those in under-developed nations, as well.

"As a member of the NRECA board, Perry served on the International Foundation committee, an effort by the US electric cooperatives to build electric cooperative systems in third

world countries," explained Stuart Lowry, Sunflower's president and CEO. "Perry travelled to Nicaragua, Haiti, Dominican Republic, Guatemala and all over the Philippine islands with other cooperative members and shared his experience of cooperative governance."

Rubart will be inducted into the Hall of Fame on March 28 in Wichita. Also to be inducted is Pete Anderson, who's been a member of the co-op family for more than 35 years as a local manager of a farmer's cooperative. Anderson was a leading force in the Kansas Cooperative Council's work with Kansas State University to establish the Arthur Capper Cooperative Center.

After a reception and dinner, Rubart and Anderson will be honored for their commitment to the growth and development of the cooperative movement. Rubart is sponsored by Pioneer, and Anderson is sponsored by CoBank, Wichita.

The two inductees' biographical information will be placed alongside other honorees in the Kansas Cooperative Hall of Fame showcase display at the Kansas State Fairgrounds. Located in the Pride of Kansas Building, this permanent display highlights the achievements of our state's great co-op leaders and preserves our co-op history. It also plays a significant role in educating others about the uniqueness of the cooperative business model.

Since it was established in 1999, 29 individuals from all types of cooperatives have been inducted into the Kansas Cooperative Hall of Fame. Each December, the Council asks for nominations for additional inductees.

#### **Sedgwick County energizes new** substation

Sedgwick County energized its new Maize Substation last month. The substation has a 25 MVA transformer and will provide power to the eastern edge of the co-op's service territory.

The total cost of this new substation, located in Sedgwick County, is estimated around \$1,360,000.

The co-op is also building 3.75 miles of new electric distribution line to connect this substation to its existing electric plant.

### Electric co-ops participate in Topeka Farm Show

The event lasted three days and over 300 exhibitors were in attendance. An

estimated 30,000 people - most of them from rural communities served by electric cooperatives - attended the show.

The co-ops' booth included a display of the electric usage of CFL and incandescent light bulbs, as well as a ticket booth to win an electric barbeque

#### **Sunflower schedules LIDAR** analysis

Sunflower has scheduled a Light Detection and Ranging (LIDAR) analysis for approximately 1,900 miles of its transmission lines.

The helicopter flyover was originally scheduled to begin Dec. 27, however due to the snow storm that hit most of the western part of the state and a maintenance issue with the aircraft, the start date was delayed.

The flyover, which will be conducted seven days a week, is now scheduled to begin flying over the transmission system on Jan. 22, and will last seven to eight weeks contingent on the weather.

The testing will ensure that Sunflower has accurate images of the current transmission system.
