Two Midwest Energy employees are now certified with Energy Star.

In order to receive this designation, Dreiling and Swob had to first become registered as energy raters, and then undergo the additional training. This

credential allows them to inspect homes and qualify them for the energy star program.

The Energy Star program hasn't seen a lot of participation in western Kansas. The raters' certification, however, could help change that. In order to maintain their certification, some Energy Star homes must be built in the area, which means the raters are actively seeking to build relationships with entities that can take part in this process.

"We're trying to get the homebuilders on board as well as the heating and cooling guys," Dreiling said.

The Energy Star qualification is beneficial for homes, as well. The process of qualifying for the home is like a building qualification. Raters look at a variety of factors including how the roof is installed and how rain water will flow away from the home.

"It's not just the insulation; it goes above and beyond—it's the entire package of the house," Swob said.

NRECA CEO expresses disappointment with proposed EPA greenhouse gas regulation

NRECA CEO Glenn English made the following statement on the Environmental Protection Agency's (EPA's) proposed greenhouse gas regulation:

NRECA and its member co-ops are extremely disappointed to learn that the Obama Administration, in a New Source Performance Standard issued today by the EPA, has jettisoned American coal from the President's all-of-the-above energy strategy. Because commercially viable carbon capture and storage technology is still years away, the rules issued by EPA have the practical effect of outlawing coal as a fuel source for the next generation of power plants. Alternatively, America's co-ops support an energy policy that maximizes energy efficiency and truly embraces all domestic fuels: nuclear, natural gas, renewable and coal.

Duke Energy and Sumitomo to jointly own Kansas wind farms

Sumitomo Corp. of America (SCOA), part of Tokyo-based Sumitomo Corp., will become a 50-50 equity partner in two large-scale wind farms Duke Energy Renewables is building in Kansas.

SCOA is buying a 50 percent stake in the 131-megawatt (MW) Cimarron II Windpower Project in Gray County and the 168-MW Ironwood Windpower Project in Ford County.

Duke Energy and SCOA will complete construction of both wind farms later this year. Duke Energy will operate and maintain Cimarron II and Ironwood once they are in service, with SCOA actively involved in management of the projects.

KEC offers NRECA supervisory training May 22-23 in Wichita

KEC is offering the last four of the NRECA Supervisory Training courses on May 22-23, 2012, at the Hotel Old Town in Wichita.

This program delivers instruction on core competencies required of supervisors in

the areas of leadership, communication, and basic administrative skills. NRECA developed the curriculum based on a set of supervisory competencies identified by new cooperative supervisors, experienced supervisors, and CEOs.

Bryan Singletary, NRECA, will facilitate these courses. To earn the supervisory certificate, all nine interactive, co-op specific half-day courses must be completed. All co-op employees are welcome to attend these training dates, regardless if they attended the first half of the training in December. If
