Making a Difference

The KEC Foundation Board would be responsible for reviewing funding opportunities, determining recipients, and reporting to the full KEC Board. Possible funding could include:

- ▶ NRECA International Program (participation requires significant local funding)
- ▶ New scholarship incentives to pay for the education of graduates who return to work at an electric cooperative
- ▶ Education projects that would enhance cooperative awareness
- ▶ Safety presentations for schools and emergency personnel
- ▶ Funding of special requests to benefit rural projects sponsored by 501(c)(3) designated organizations
- ▶ Underwrite event or broadcast programming that celebrates rural Kansas
- ▶ Sponsor special projects such as a Children's Energy Park at the National Agricultural Hall of Fame in Bonner Springs

Chartering & Managing the Foundation
